Waiver and Release of Liability

By signing this form, I, the undersigned participant, agree to the following:

1. Eligibility

I affirm that I am 21 years of age or older and understand that no individuals under 21 are permitted at The MeatUp, under any circumstances. A valid government-issued ID may be required for entry.

2. Assumption of Risk

I understand that my participation in The MeatUp is voluntary and may involve consumption of food and alcoholic beverages, physical activity, and close interaction with other attendees. I knowingly and freely assume all risks associated with attending this event, including but not limited to illness (including food borne or communicable diseases), injury, allergic reactions, or any other hazards that may arise.

3. Release of Liability

I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, hereby release, waive, and discharge The MeatUp organizers, event staff, sponsors, venue owners, affiliates, and volunteers from any and all liability, claims, demands, or causes of action arising out of or related to any loss, damage, injury, or illness I may sustain while participating in or attending the event, whether caused by negligence or otherwise.

4. Alcohol and Conduct

I understand that alcohol may be served or consumed at this event. I agree to drink responsibly and comply with all local, state, and federal laws. I take full responsibility for my actions and behavior during the event. The organizers reserve the right to remove any participant for inappropriate, unsafe, or unlawful behavior without refund.

5. Zero-tolerance Drug Use Policy

I acknowledge that the MeatUp Group Inc has a zero-tolerance drug use policy. If I or anyone in my party is found in possession of, or under the influence of, illegal drugs or drug paraphernalia, the results may include removal, permanent banishment from the venue(s) and potential police involvement. The organizers reserve the right to remove any participant for inappropriate, unsafe, or unlawful behavior without refund.

6. Medical Treatment

In the event of an injury or medical emergency, I authorize the event organizers to seek medical treatment on my behalf and accept full responsibility for any associated costs.

7. Photographic Release
